Noise and soundscape action plan 2018-2023

Date of issue: 11 July 2018

Overview

The Welsh Government is inviting comments on its draft noise and soundscape action plan for the period 2018-2023. It replaces the current noise action plan for Wales, adopted in 2013. Environmental noise legislation requires national noise action plans to be reviewed and revised, where necessary, at least every five years.

Noise means unwanted or harmful sound, while the term “soundscape” refers to the acoustic environment as perceived, experienced or understood by people in any given context. This includes beneficial and neutral sounds as well as noise.

The noise and soundscape action plan is the Welsh Government’s central noise policy document, and has been produced collaboratively with local authorities and other public bodies. It outlines the Welsh public sector’s strategic policy direction in relation to noise and soundscape management for the next five years.

Besides stressing the importance of considering soundscapes in the round, in addition to controlling levels of noise, the main differences between the draft 2018 plan and the current plan are as follows:

- The draft plan aligns noise and soundscape policy in Wales with the cross-cutting framework established by the Well-being of Future Generations (Wales) Act 2015.
- The draft plan encourages greater integration between noise and air quality management activities by public bodies, so as to achieve multiple benefits.
- The draft plan highlights the proposed updates to national planning policy and guidance in Wales that relate to noise and soundscape.

The Welsh Government would welcome your views on the proposed content of the 2018 noise and soundscape action plan.

Please note that the accompanying document, “Noise and soundscape action plan 2018-2023 – consultation draft” should be read prior to answering the consultation questions.

If you do not want your name or address published, please tell us this in writing when you send your response. We will then redact them before publishing.

If your details are published as part of the consultation response then these published reports will be retained indefinitely. Any of your data held otherwise by Welsh Government will be kept for no more than three years.

Your rights

Under the data protection legislation, you have the right:
